January 2013 compared with December 2012


Euro area production in construction down by 1.4%

Down by 1.3% in EU27

In the construction sector, seasonally adjusted production¹ fell by 1.4% in the **euro area**² (EA17) and by 1.3% in the **EU27**² in January 2013, compared with the previous month, according to first estimates released by **Eurostat, the statistical office of the European Union**. In December 2012³, production increased by 0.3% in the **euro area**, but declined by 0.6% in the **EU27**.

Compared with January 2012, production in January 2013 dropped by 7.3% in the **euro area** and by 8.0% in the **EU27**.

As announced in the previous News Release, from January 2013 onwards indices for production in construction are calculated and presented with 2010 as the new base year. See annex for more details.



Monthly comparison

Among the Member States for which data are available for January 2013, production in construction fell in nine and rose in four. The largest decreases were registered in **Slovenia** (-7.4%), **Sweden** (-5.1%), the **Czech Republic** (-4.4%) and **France** (-4.0%), and the increases in **Poland** (+5.3%), **Bulgaria** (+3.7%), **Germany** (+3.0%) and **Portugal** (+1.2%).

Building construction decreased by 1.0% in the **euro area** and by 1.3% in the **EU27**, after +0.1% and -0.7% respectively in December 2012. Civil engineering fell by 3.2% in the **euro area** and by 1.7% in the **EU27**, after +0.5% and -1.1% respectively in the previous month.

Annual comparison

Production in construction fell in all Member States for which data are available for January 2013. The largest decreases were registered in **Slovenia** (-22.1%), **Portugal** (-20.2%), **Poland** (-17.3%), **Slovakia** (-14.9%) and the **Netherlands** (-13.7%).

Building construction declined by 7.3% in the **euro area** and by 7.7% in the **EU27**, after -5.1% and -6.1% respectively in December 2012. Civil engineering decreased by 8.9% in the **euro area** and by 9.5% in the **EU27**, after -3.0% and -10.8% respectively in the previous month.

1. The index of production in construction approximates the evolution of the volume of production within the sector, broken down into building construction and civil engineering. For the Member States which produce the construction index, but do not provide data for the reference period, Eurostat estimates missing values in order to calculate euro area and EU aggregates.

For total construction, and according to the Council Regulation 1165/98, Eurostat publishes national seasonally adjusted data if available. For Denmark, Estonia, Greece, Spain, Cyprus, Luxembourg, the Netherlands and the United Kingdom, Eurostat makes the adjustment.

The seasonally adjusted euro area and EU series for production in construction are calculated by aggregating the seasonally adjusted national data. The monthly index as presented in this News Release is calculated only on the basis of the data of those countries reporting monthly data.

2. The euro area (EA17) includes Belgium, Germany, Estonia, Ireland, Greece, Spain, France, Italy, Cyprus, Luxembourg, Malta, the Netherlands, Austria, Portugal, Slovenia, Slovakia and Finland.
The EU27 includes Belgium (BE), Bulgaria (BG), the Czech Republic (CZ), Denmark (DK), Germany (DE), Estonia (EE), Ireland (IE), Greece (EL), Spain (ES), France (FR), Italy (IT), Cyprus (CY), Latvia (LV), Lithuania (LT), Luxembourg (LU), Hungary (HU), Malta (MT), the Netherlands (NL), Austria (AT), Poland (PL), Portugal (PT), Romania (RO), Slovenia (SI), Slovakia (SK), Finland (FI), Sweden (SE) and the United Kingdom (UK).
3. Data of previous months have been revised compared to those issued in News Release 26/2013 of 19 February 2013. The monthly growth rates for December 2012 have been revised from -1.7% to +0.3% in the euro area and from -2.7% to -0.6% in the EU27. The annual growth rates have been revised from -4.8% to -4.6% in the euro area and from -8.5% to -7.0% in the EU27.
