Summary of the results of the 4th meeting of the "Council for International Development of Aviation Infrastructure"

~Focus support on Palau, Mongol and Vietnam etc. this fiscal year~

Ministry of Land, Infrastructure, Transport and Tourism (MLIT) held the fourth meeting of the "Council for International Development of Aviation Infrastructure" on June 1. The main attendees were Mr. Imai, Honorary Chairman, Nippon Steel & Sumitomo Metal Corporation representing the private sector and Mr. Sato, Director-General, Civil Aviation Bureau representing MLIT.

Both the private and government side overviewed the undertakings up to the present and made remarks on future action plans during the Council meeting.

The Council has decided to focus support on the projects whose orders would be ensured or acceleration would be expected especially in Palau, Mongol, Vietnam and so on.

<Summary of the proceedings>

- 1. At the start of the meeting, Chairperson Imai made remarks to the effect that it is required to promote a strategic approach which should result in concrete results and therefore the public-private collaborative initiative is highly expected. Director-General Sato commented that the Council has been promoting our aviation infrastructure business internationally and MLIT will further take positive actions such as an implementation of top-level sales.
- 2. During the discussion on the agenda of past activities and future action plans, the results of the past activities such as overseas visit missions and top-level sales were highlighted by the government and private side respectively.
- 3. The Council has decided, as a policy of this fiscal year, taking into consideration of Council members' intentions and the surrounding situations, to take further positive actions to secure aviation infrastructure projects, especially in Palau, Mongol, Vietnam and so on.
