Holding of the explanatory meeting about the Application Guidelines etc.

- Date : From 16:00 on Thursday, 22 March 2018

- Application : If you would like to attend the explanatory meeting, please send by email a completed “Entry form for the explanatory meeting about the Application Guidelines etc. (Exhibit 1)” by the application deadline to the Bidding Advisor and submit the original at the explanatory meeting on the day. Entry forms shall be prepared with Microsoft Excel. No applications by any method other than the above shall be accepted.

- Application deadline : No later than 13:00 on Tuesday, 20 March 2018
- Notes : Participants in the explanatory meeting are required to bring a copy of the Application Guidelines etc. (No distribution at the venue)
Participants shall refrain from taking photographs or making video recording.

Receipt of questions about the Application Guidelines etc. and publication of answers

- Receiving period : From 10:00 on Monday, 26 March 2018
1st deadline: No later than 15:00 on Thursday, 12 April, 2018
2nd deadline: No later than 15:00 on Thursday, 10 May 2018
- Submission method : Questions concerning the Application Guidelines etc. shall be briefly stated in the questionnaire (which can be obtained by electromagnetic means: so called Virtual Data Room, hereinafter called VDR) specified in the Forms and Directions (Japanese only), and transmitted via VDR.
If the questions contain any content (such as special techniques and know-how) which might infringe on the rights, competitive position, or other reasonable interest of the submitter if the questions are disclosed,

the submitter shall make a statement to that effect.

The questionnaire shall be prepared with Microsoft Excel, and the company name, department name, full name, telephone number and email address of the submitter shall be filled in. Questions submitted by methods other than VDR shall not be accepted.

- Publication of answers : If the State deems necessary, it will publish questions concerning the Application Guidelines etc. and the answers to these questions excluding those which might infringe on the rights, competitive position, or other reasonable interest of the submitter as so stated by the submitter upon its submission, by the planned publication date of answers on the website of Civil Aviation Bureau of MLIT or by other appropriate means. For a fair treatment of all questions, the State will not provide answers directly to the submitter of the corresponding questions.

Planned publication date of answers: Friday, 25 May 2018

Final answers will be made on this day, however, questions received will be published in a phased manner prior to this date.
