Receipt of questions about the Application Guidelines etc. and publication of answers

- Submission period : We will accept questions following period
1st : From 10:00 on Wednesday,30 May to 15:00 on Thursday, 31 May 2018.
2nd : From 10:00 on Monday,9 July to 15:00 on Tuesday , 10 July 2018
- Submission method : Questions concerning the Application Guidelines etc. shall be submitted via the Virtual Data Room (hereinafter “VDR”) using the Questionnaire in the Forms and Directions. The questions must be succinct and submitted in Japanese (An English translation may be posted alongside the official Japanese question).
If the questions contain any content which might infringe on the rights, competitive position, or other reasonable interest of the submitter if the questions are disclosed (i.e. techniques and know-how unique to the submitter), the submitter shall make a statement to that effect.
The Questionnaire shall be prepared with Microsoft Excel, and the

company name, department name, full name, telephone number and email address of the submitter shall be filled in. Questions not submitted via the VDR shall not be accepted.

- Publication of answers : If MLIT, Asahikawa City, Obihiro City and Hokkaido Prefecture deem necessary, it will publish the answers to the questions concerning the Application Guidelines etc. excluding those which might infringe on the rights, competitive position, or other reasonable interests of the submitter as so stated by the submitter upon its submission by the date below. This will be posted on all the websites of Civil Aviation Bureau of MLIT , Asahikawa City, Obihiro City, Hokkaido Prefecture or by other appropriate means. For the fair treatment of all submitters, MLIT, Asahikawa City, Obihiro City and Hokkaido Prefecture will not provide answers directly to the submitter of the corresponding questions.

Final answers will be made on this day, however, answers are planned to be published in a phased manner prior to this date.
