DESCRIPTION OF DEFECT	With regards to the shock absorber, due to inappropriate management for the tightening of the lower bolts which fix the shock absorbers to the front axle(s) and/or the upper bolts/nuts which fix the shock absorbers to the rear axle(s), some of the bolts/nuts torque may be insufficient and may become loose. Thus, if the vehicle continues operation under these conditions, the bolts/nuts may come off and one side of the shock absorber may be disconnected. In such cases the disconnected shock absorber may interfere with surrounding parts which may cause abnormal noise. Ultimately, the contacted parts may be at risk to be damaged.
