## Conclusion

About Domestic tourism consumption statistics

- Countries that do not conduct the domestic tourism consumption survey tend not to compile the TSA.
- A method that enables the compilation of the TSA using a household consumption survey or a simple tourism consumption survey is needed for some

countries. About Inbound tourism consumption surveys

- Most countries conduct an inbound tourism consumption survey, as they are heavily interested in inbound tourism.
- The number of countries that try to compile the TSA may increase if a new TSA format (or table) describing inbound tourism GDP is developed.

About Organizations responsible for compiling TSA

A new framework to exchange ideas about TSA is required in Asia.
