## Holding of the 4th meeting of the "Council for International Development of Aviation Infrastructure"

~Support Japanese companies to secure overseas aviation infrastructure projects~

Ministry of Land, Infrastructure, Transport and Tourism (MLIT) will hold the fourth meeting of the "Council for International Development of Aviation Infrastructure" on June 1. In order that Japanese companies secure various aviation infrastructure projects such as construction and operation of airports and introduction of air traffic control system mainly in Asia, it is required to further enhance the public-private collaborative initiative. To this end, the past activities are to be reviewed and the policy for future plans is to be decided in the meeting.

MLIT has set up the "Council for International Development of Aviation Infrastructure" in April 2013 to promote our aviation infrastructure business internationally through public-private collaborative initiative. Since then, we have been undertaking various activities including business matching services by taking advantage of opportunities of overseas visit missions and intergovernmental meetings.

In order that Japanese companies could secure projects in the international aviation infrastructure market on which we have been focusing, it is required to further enhance the public-private collaborative initiative. To this end, the fourth Council meeting will be held to review the past efforts and to decide the policy for future plans as below.
