2001

In response to the 9/11 terrorist attacks, the UN Tourism established the **Tourism Recovery Committee** to assess the state of the tourism industry and recovery strategies.

SARS 2008

Financial crisis 2009

2017

Designated as the **International Year of Sustainable Tourism for Development**, saw the adoption of the Montego Bay Declaration, which emphasized ;

- (1) Global and local governments as well as public-private partnerships,
- (2) The integration of the tourism sector into crisis management and post-crisis response frameworks.

2019

The **Kutchan Declaration** was adopted at the G20 Tourism Ministers' Meeting, outlining voluntary measures to enhance tourist protection and strengthen the sector's recovery capabilities.

Covid-19 2019

2020

The G20 and the World Travel & Tourism Council (WTTC) confirmed the critical role of public-private collaboration in recovering from the COVID-19 pandemic. They jointly launched the **100 Million Jobs Recovery Plan**, which emphasizes continued investment in crisis preparedness and resilience.

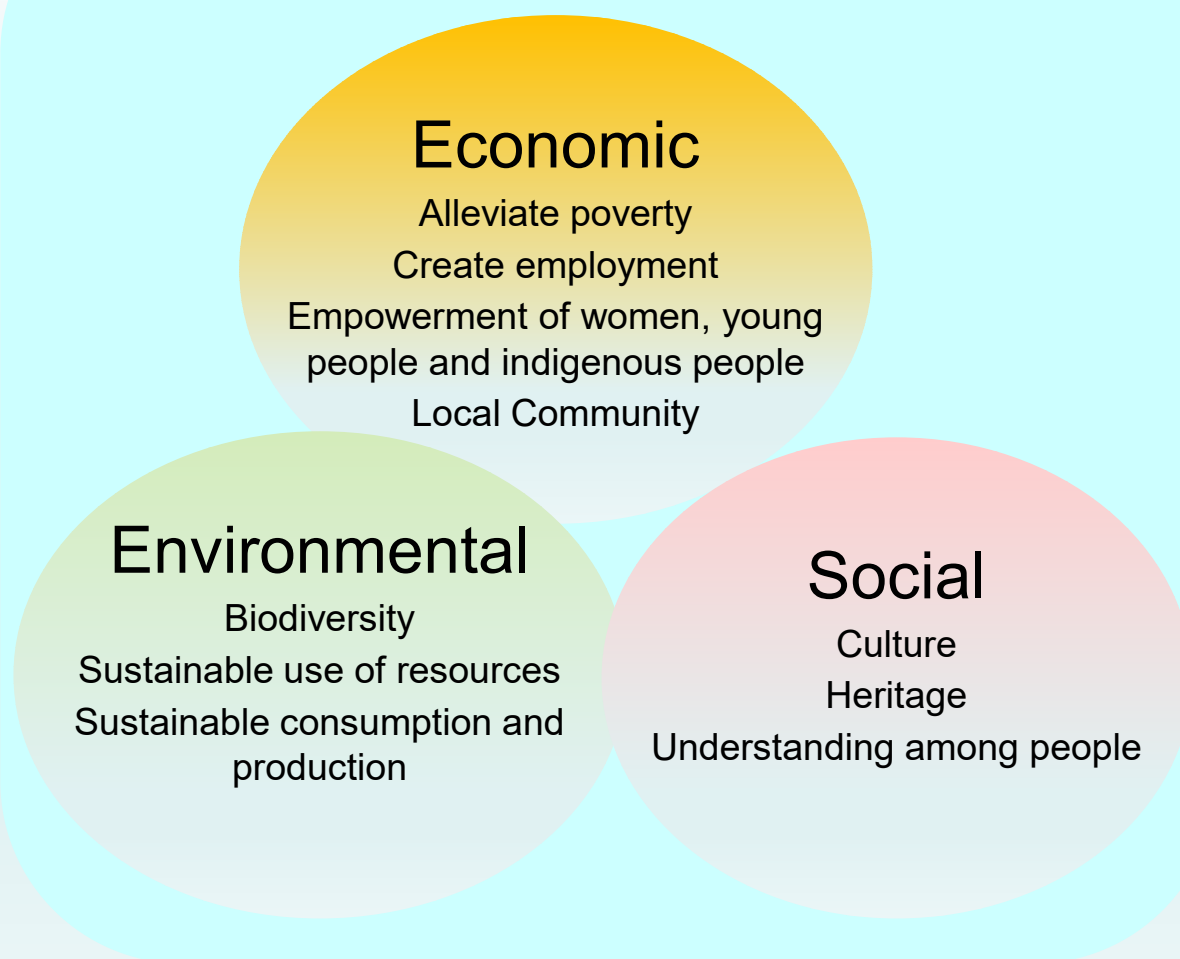
2023

UN Tourism formally declared February 17 as **Tourism Resilience Day**.

International Year of Sustainable and Resilient Tourism, 2027

On February 2024, the UN General Assembly unanimously adopted a resolution proposed by Uzbekistan designating 2027 as the International Year of Sustainable and Resilient Tourism.

Risk Assessment

Anticipating and evaluating risks based on the geographical conditions and characteristics of the tourism industry in each region, subsequently applying this knowledge to the tourism sector.

Guideline to Tourism Crisis Management Planning by Japan Tourism Agency

Create tourism risk matrix for the region for each stage of the 4Rs (Reduction, Readiness, Response, Recovery)

- What are the possible crises?
- Who needs to be taken into consideration?
- Who will play which role?



Promote local government and DMOs to develop tourism risk management plans based on this guideline

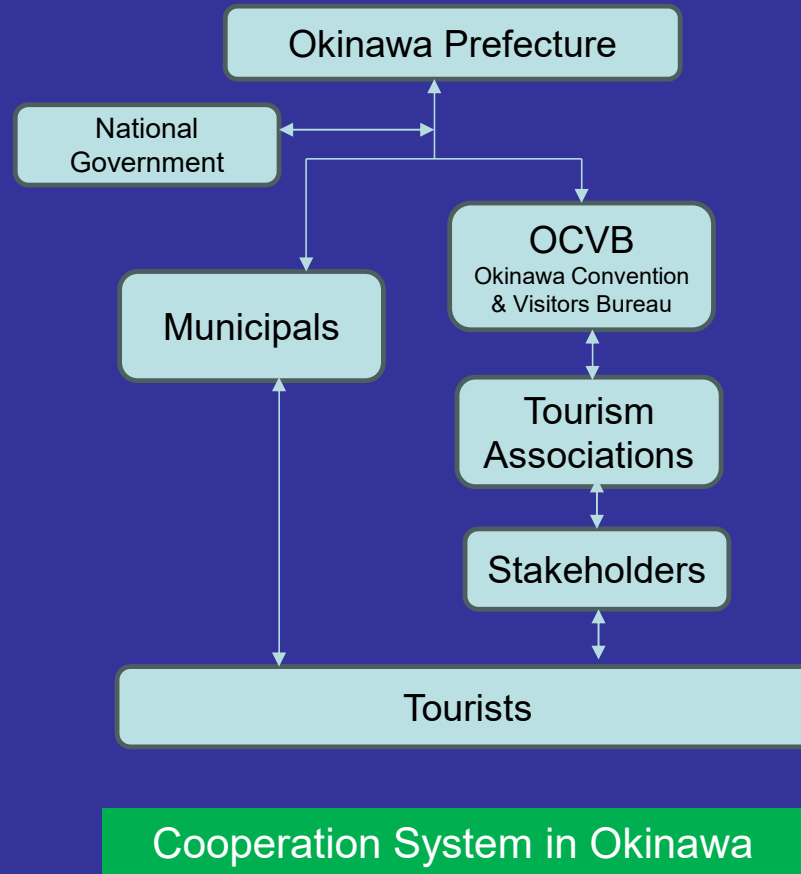
Summarize Impact on tourists
